#### - Enter the following information on the Header:

**CONTAINER/TRAILER/VEHICLE REG No** – Enter container, trailer and/or vehicle registration number and indicate if it is an ambient, chilled or frozen box.

**ETA** – Enter the estimated date and time of arrival.

**QUANTITIES** – Indicate the total number of packages, net and gross weights for the consignment of foodstuffs.

#### - For all the foodstuffs in the container/trailer/vehicle, complete the following information:

**Product Name** – Give details (product's name and brand, etc.) for each of the products.

**CN Code** – Enter CN Code for the product as per Customs declaration.

**Type of Product** – Indicate the type of foodstuff (i.e. Biscuits, Confectionery, Sauces, Chocolate, Crisps, Food Supplements, etc.)

Quantity – enter the number of packages and the weights for the product.

## High Risk Ingredients – These are either Products of Animal Origin (POAO) or High-Risk Food and Feed Not of Animal origin (HRFNAO).

- > Products of animal origin (**POAO**) include:
  - meat and meat products including extracts, stocks, concentrates and powders;
  - fish and fishery products;
  - milk and dairy products such as whey, caseinates, milk powders, butter, cream, cheese, buttermilk, etc.;
  - eggs and egg products;
  - collagen;
  - gelatine of animal origin;
  - di and tri-calcium phosphate of animal origin;
  - honey;
  - amino acids of animal origin;
  - creatine of animal origin.

This list of products of animal origin is not exhaustive. All ingredients of animal origin, including those in flavourings must be declared. If the product has different ingredients of animal origin, list ALL ingredients and their percentages.

High-Risk Food and Feed Not of Animal origin (HRFNAO) are certain products that come from specific countries. Whilst there is currently no HRFNAO originating from within the EU, these requirements will apply to non-EU country HRFNAO imported into the EU and subsequently exported to the UK.

For example, see ingredients that can be HRFNAO: Groundnuts, Hazelnuts, Brazil nuts, Nutmeg, Peppers, Sesamum Seeds, Guar Gum, Pistachios, Watermelon seeds, Figs, Vine Leaves, Dragon Fruit, Ginger, Saffron, Turmeric (curcuma), Thyme, Bay leaves, Curry and other spices

In many cases it is not just the raw material that is covered, some products containing more than 20% of the controlled product are also covered by import conditions.

List ALL High Risk ingredients and their percentages in the final foodstuff.

The High Risk ingredients must be listed as appearing on the labels/accompanying documents (i.e. whey powder, albumin powder). General descriptions like milk, dairy, egg are not acceptable.

DO NOT list other ingredients which are not High Risk ingredients (i.e. sugar, flour, etc.)

If the foodstuff has no High Risk ingredients, enter "No High Risk Ingredients".

**Country of Origin of High Risk Ingredient** – Enter the country of origin of the High Risk ingredient, not of the final product. If the product has different High Risk ingredients, list the countries of origin for each ingredient in order as you listed the High Risk Ingredients. If the foodstuff has not High Risk ingredients, enter "N/A".

**Treatment of POAO Ingredient** – Enter the heat treatment for the ingredient of animal origin. This should be a combination of temperature and time.

Treatment is not needed for Gelatine or Honey.

Please attach to this signed declaration any supporting documentation like manufacturer's declarations, etc. to substantiate the details on the declaration. By 'manufacturer's declaration' we mean a Declaration from the manufacturer of the final product indicating % of POAO/s on that product, country/ies of origin of the POAO/s and heat treatment the POAO went through at source and before it was added to the final product's mix.

If the products containing ingredients of animal origin are not shelf-stable at ambient temperature, also attach flow charts of their manufacturing process.

We reserve the right to request further guarantees with regards the foodstuffs and to carry out checks on the paperwork provided and/or the labels of the products, to verify the information contained on this declaration.

All the ingredients of animal origin (except wild caught fish, gelatine and collagen) must originate in a country with an approved residue plan for the product as per the <u>Annex to Commission Decision 2011/163/EU</u>. Otherwise, they cannot be imported.

Any dairy ingredients included in any foodstuffs must only be derived from, and treated as provided for, countries listed in <u>Annex I to Commission</u> <u>Regulation (EU) No 605/2010</u>

From 1 January 2022, all Products of Animal Origin (POAO), Animal By-Products (ABP) and High Risk Foods Not of Animal Origin (HRFNAO) consignments from **European Union (EU)** into Great Britain (GB) need to be pre-notified on the Import of products, animals, food and feed system (IPAFFS).

Last updated 15/12/2021

We will introduce certification, documentary, ID and physical checks, by commodity groups for products of animal origin, animal by-products, plant and plant products, in three phases between 1 July and 1 November 2022. The timetable is as follows:

- From 1 July, certification and physical and identity checks will be introduced for:
  - All remaining regulated animal by-products
  - All regulated plants and plant products
  - All meat and meat products
  - All remaining high-risk food not of animal origin.
- > From 1 September, certification and physical checks will be introduced for all dairy products.
- From 1 November, certification and physical checks will be introduced for all remaining regulated products of animal origin, including composite and fish products.

Consignments of these products from **Rest of the World (RoW) country** are already subject to official controls at border control posts. For further reference, please see the <u>Annex I to Commission Regulation (EU) No 2019/2007</u>; and, <u>Commission Decision 2007/275/EC</u> concerning lists of composite products to be subject to controls at border control posts; in particular, <u>Article 6 Derogation for certain composite products</u>.

At the moment, the BCP at Dover Port is currently approved only for:

- Pistachios from Iran,
- Pistachios from Turkey,
- Figs from Turkey,
- Hazelnuts from Turkey.

Any other consignment of these high-risk products from a RoW country not covered by the commodities listed above will not be able to enter via Dover unless it has been 'EU cleared' where it will be treated as EU origin.

- High Risk Non-animal origin products requiring a CHED but no health certificate required (See Annex I for product list)
- Food and feed products of a known contamination risk by mycotoxins, including aflatoxins, pesticide residues, pentachlorophenol and dioxins and microbiological contamination requiring a CHED and health certificate (<u>See Annex II for product List</u>)
- Food and feed from certain third countries banned (See Annex IIa for product List)
- Food or feed from Japan will need to follow the import requirements laid down in UK retained <u>Commission Implementing Regulation (EU)</u> <u>2016/6</u> (as amended).
- Food and feed originating in third countries following the accident at the Chernobyl nuclear power station <u>Commission Implementing</u> <u>Regulation (EU) 2020/1158</u> (as amended).
